

Competition Terms & Conditions

Hennie's "Sit My Op CBB" Competition

July 2026

This "Sit My Op CBB" Competition ("Competition"), proudly sponsored by Edward Snell & Co Ltd and brought to you by Hennie's Sports Bar (Pty) Ltd ("Hennie's"), is offered subject to the terms and conditions set out below. "CBB" refers to the "Chat 'n Bietjie Ball" show.

Participation by entrants in the Competition constitutes an agreement to abide by all these terms and conditions. Hennie's reserves the right to disqualify any entrant who breaches any provision(s) hereof.

1. COMPETITION OVERVIEW

1.1. 1 (One) cash prize of R20,000.00 (Twenty Thousand Rand), which amount is inclusive of VAT, if any, is available to be won ("Prize"), together with the opportunity to feature as a guest on an episode of Chat 'n Bietjie Ball, recorded at a studio.

1.2. The cash portion of the Prize will be paid via EFT to the winner, on the basis set out under 'The Prize' below.

1.3. This Competition runs from 3 July 2026 to 6 November 2026 ("Promotion Period").

2. WHO CAN ENTER?

2.1. Entrants must be 18 (eighteen) years of age or older to enter this Competition.

2.2. This Competition is open to entrants of all participating Hennie's branches in South Africa and Namibia.

2.3. Entrants must submit their entry through, a Hennie's App account registered in their own name.

2.4. Each entry must be supported by a genuine qualifying purchase made by the entrant personally, and a valid till slip reflecting that purchase.

2.5. Employees, officers, contractors, franchisees, and their immediate families (spouse, children, parents, and siblings) of Hennie's, Edward Snell & Co Ltd. or of any agency or company associated with this Competition, are not eligible to enter.

3. HOW TO ENTER

3.1. To enter the Competition, the entrant must:

3.1.1. purchase 1 (one) Firewater shot at a participating Hennie's branch;

3.1.2. download or open the Hennie's App;

3.1.3. tap the "CBB Sit My Op" button;

3.1.4. select "Scan to enter"; and

3.1.5. scan the valid till slip reflecting the qualifying purchase.

3.2. Each successfully completed and validly scanned entry, supported by a unique qualifying till slip, constitutes one (1) entry into the Competition draw.

3.3. Entrants may enter as many times as they wish during the Promotion Period, provided that each entry is supported by a separate qualifying purchase and a distinct, valid till slip. The same till slip may not be used to submit more than one entry, and any attempt to do so will result in disqualification of the duplicate entry or entries.

3.4. It is the entrant's responsibility to ensure that their entry is successfully submitted via the Hennie's App. Hennie's is not responsible for entries that are not received due to App malfunction, network failure, or any other technical issue outside of our reasonable control.

4. THE DRAW AND WINNER SELECTION

4.1. The winner will be selected by means of a random draw from all valid entries received during the Promotion Period.

4.2. Hennie's may use an appropriate electronic or automated random selection method to conduct the draw.

- 4.3. Following the final draw, Hennie's will vet the potential winner to ensure compliance with all entry requirements. The Winner will be announced within 10 business days of the competition closing date via Hennie's official social media platforms, unless that timeline is physically impossible.
- 4.4. Hennie's will attempt to contact the potential winner via telephone and email for a maximum of 48 (forty-eight) hours. If the potential winner is unreachable within this timeframe, they will forfeit the prize and a new winner will be drawn. Once confirmed, the winner will be presented with the date of the next available CBB studio recording.
- 4.5. Hennie's' decision regarding the draw, verification, and winner selection is final and binding. No correspondence will be entered into.

5. VERIFICATION

- 5.1. Hennie's reserves the right to verify all aspects of an entry, including but not limited to:
- 5.1.1. that the qualifying purchase was genuinely made by the winner at a participating Hennie's branch;
 - 5.1.2. the authenticity of the till slip scanned;
 - 5.1.3. that the winner is the lawful holder of the Hennie's Apps account used to submit the entry;
 - 5.1.4. the winner's identity, age, and eligibility to participate; and
 - 5.1.5. that the entry was not submitted in breach of these terms and conditions.
- 5.2. The winner must cooperate fully with any verification request. Failure to provide the requested verification within 7 (seven) calendar days of our request will result in disqualification, and Hennie's will conduct a further draw as described above.
- 5.3. Hennie's reserves the right to disqualify any entry or entrant that we reasonably believe:
- 5.3.1. contains false, misleading, or fraudulent information;

- 5.3.2. involves duplicate, manipulated, or fraudulently obtained till slips or entries;
- 5.3.3. violates any provision of these terms and conditions;
- 5.3.4. was submitted by a person who is not eligible to enter; or
- 5.3.5. is contrary to the spirit or intention of the Competition.

6. THE PRIZE

6.1. The Prize consists of:

- 6.1.1. R20,000.00 (Twenty Thousand Rand) in cash, payable via EFT ("cash Prize");
and
- 6.1.2. the opportunity to feature as a guest on an episode of Chat 'n Bietjie Ball, recorded at a studio, on a date arranged as set out further below.

6.2. The winner's entitlement to the cash Prize is not conditional upon the winner's attendance at, or participation in, the CBB studio recording referred to above. The cash Prize will be paid in accordance with these terms regardless of whether the studio recording takes place, save that the winner remains obliged to comply with the requirements set out below in this section.

6.3. The winner must provide the following information ("required information") within 7 (seven) days of being notified that they are the winner:

- 6.3.1. full legal name as it appears on their ID/passport;
- 6.3.2. contact telephone number and email address;
- 6.3.3. proof of banking details, supplied by their bank, into which the cash Prize will be transferred; and
- 6.3.4. a signed acknowledgment of receipt of the Prize and agreement to these terms, including the publicity and media terms set out below.

6.4. The cash Prize will be paid via EFT into the winner's nominated bank account within 7 (seven) working days of our receipt of the required information. Hennie's shall not be liable for any incorrect banking details provided by the winner.

- 6.5. The Prize is not transferable, not exchangeable, and has no alternative cash value beyond the cash Prize amount stated above. The winner may not sell, assign, or transfer their right to receive the Prize to any other person.
- 6.6. Hennie's reserve the right to substitute the cash Prize with an alternative prize of equal or greater value, or to adjust the arrangements for the CBB studio appearance, where payment or performance becomes impossible or impractical for reasons beyond our reasonable control.
- 6.7. As part of accepting the Prize, the winner agrees to make themselves reasonably available to attend a recording of a Chat 'n Bietjie Ball episode, as a guest, at a Hennie's studio, on a date and time arranged by Hennie's in reasonable consultation with the winner.
- 6.8. Hennie's will give the winner reasonable advance notice of the proposed recording date.
- 6.9. If, despite reasonable efforts, the winner is unable to attend the studio recording (for example, due to genuine personal, health, or travel constraints), Hennie's may, at our sole discretion, arrange an alternative form of participation, or proceed without the winner's appearance. This will not affect the winner's entitlement to the cash Prize.
- 6.10. Should the winner be required to travel to attend the studio recording, the following travel arrangements apply:
- 6.10.1. South African winners: Hennie's will arrange and cover the cost of transport and one night's accommodation from the winner's location within South Africa to the studio recording venue and back.
- 6.10.2. Winners outside South Africa: The winner is responsible for arranging and funding their own travel and required travel documentation (including a valid passport) to OR Tambo International Airport, Johannesburg. From OR Tambo, Hennie's will arrange and cover transport and one night's accommodation to the studio recording venue and back to OR Tambo.
- 6.11. The winner must ensure that all required travel documents are in order prior to the recording date. Hennie's accepts no responsibility for any failure to attend the

studio recording due to the winner's failure to obtain the necessary documentation or to travel to OR Tambo.

7. TAX

7.1. The winner is solely responsible for any tax implications arising from receipt of the Prize and is advised to seek independent tax advice. Hennie's makes no representation regarding the tax treatment of the Prize in the hands of the Winner.

7.2. Hennie's will not withhold any amount from the Prize in respect of tax, and the full cash Prize amount will be paid to the winner, save as may be required by law.

8. MEDIA, APPEARANCE, AND CONTENT RIGHTS

8.1. By accepting the Prize, the winner consents to being filmed, photographed, and recorded for purposes of the CBB studio appearance referred to under 'The Prize' above, and grants Hennie's a perpetual, worldwide, royalty-free, non-exclusive licence to use, reproduce, edit, broadcast, publish, and otherwise exploit such footage, recordings, and material (including the winner's name, image, voice, and likeness) for marketing, promotional, and commercial purposes across all media platforms.

8.2. The winner agrees that Hennie's may publish the winner's name and/or likeness in connection with the Competition and the announcement of the winner, on Hennie's social media platforms, website, and other channels.

8.3. The winner warrants that they have the legal capacity to grant the licence referred to above and indemnifies Hennie's against any claim arising from a breach of this warranty.

9. OTHER TERMS AND CONDITIONS

9.1. Hennie's reserves the right to cancel, suspend, modify, or terminate this Competition at any time without prior notice, for any reason, including but not limited to fraud, technical difficulties, supply constraints, or circumstances beyond our reasonable control. In the event of any dispute, Hennie's decision is final and binding and no correspondence will be entered into.

9.2. Hennie's is not responsible for:

- 9.2.1. any technical failure of the Hennie's App, including failure to scan, register, or process an entry;
 - 9.2.2. network, connectivity, or platform outages affecting entry submission;
 - 9.2.3. lost, late, duplicated, or incomplete entries, or illegible or damaged till slips;
 - 9.2.4. any costs incurred by an entrant in participating in the Competition, including without limitation data costs or travel expenses, save as expressly stated in these terms; or
 - 9.2.5. any damage to property or person arising from participation in the Competition, including attendance at the CBB studio recording, save to the extent caused by our gross negligence.
- 9.3. Hennie's reserves the right to amend these terms and conditions at any time by publication on its website (www.therealhennies.co.za) during the Competition period.
- 9.4. These terms and conditions are governed by the laws of the Republic of South Africa.

10. LIABILITY

- 10.1. To the maximum extent permitted by law, Hennie's Sports Bar (Pty) Ltd, Edward Snell & Co Ltd, their respective holding, subsidiary, associated, and interrelated companies, directors, officers, employees, agents, and franchisees shall not incur any liability for any injury, loss, claim, damage, or death of any nature whatsoever suffered by the Winner or their companion (whether direct, indirect, or consequential) arising from:
- 10.1.1. participation in this Competition;
 - 10.1.2. acceptance or use of the Prize; or
 - 10.1.3. travel to or from, or attendance at, any studio recording.
- 10.2. In the event of Force Majeure (including but not limited to acts of God, strike, war, riot, fire, accident, governmental restrictions, pandemics, or any circumstances

beyond the reasonable control of Hennie's), Hennie's shall be relieved of all obligations to the winner during the period such Force Majeure continues and shall not be liable for any delay, failure, or loss suffered.

11. PROTECTION OF PERSONAL INFORMATION

- 11.1. Hennie's collects entrants' and winners' personal information in order to conduct the Competition. If the requested information is not provided, the entrant may not participate. Hennie's will not disclose this information to anyone other than contractors providing services for this Competition, unless compelled or permitted by law.
- 11.2. Winner's name and images may be published on Hennie's and Edward Snell & Co Ltd's social media platforms, websites, and other marketing materials.
- 11.3. By entering the Competition, entrants agree to receive further communication and direct marketing from Hennie's and Edward Snell & Co Ltd. Entrants may opt out of commercial communications at any time via the opt-out mechanisms provided.
- 11.4. This Competition complies with the Consumer Protection Act ("CPA") and the Protection of Personal Information Act ("POPIA"). In the event of conflict between these terms and applicable legislation, the legislation shall prevail.

12. CONSENT

- 12.1. By entering this Competition, entrants voluntarily consent to:
 - 12.1.1. Hennie's processing their personal information (name, telephone number, email address, and identity number) during and after the Competition;
 - 12.1.2. Hennie's and Edward Snell & Co Ltd capturing and using their name, image, photographs, videos, and other media for promotional purposes without remuneration; and
 - 12.1.3. Participation in promotional activities as reasonably requested by Hennie's or Edward Snell & Co Ltd.
- 12.2. Entrants acknowledge they will have no proprietary rights in any media produced.
